#### KEY POINTS

- The Australian Government is awaiting receipt of an official Australian portrait of His Majesty The King from Buckingham Palace. When available, it would be appropriate to continue the practice of making The Soverign's portrait available to the public through the Nationhood Material Program, as done previously for the portrait of Her Majesty Queen Elizabeth II.
- 2. There has been a large number of requests from the public for The King's portrait in the lead up to and following the Coronation. The Department of the Prime Minister and Cabinet (PM&C) has not been provided a timeframe for the receipt of the official portrait.
- 3. The Department of Finance has recommended that the approval of the official portrait for distribution through the Nationhood Material Program be in place prior to the receipt of the portrait. This would assist in minimising any further delays in the portrait being made available to the public.
- 4. The letter to the Senator the Hon Don Farrell, the Special Minister of State (Minister Farrell), seeks his agreement to include the official Australian portrait of The King in the Nationhood Material Program in advance of its receipt from Buckingham Palace (Attachment A).
- 5. Following approval, the Department of Finance will make the appropriate arrangements to have the portrait available for Parliamentarians to order, and will update the relevant guidance material on the Ministerial and Parliamentary Services website.
  - a. The letter provides a contact point within PM&C to assist in those arrangements.

#### SUPPLEMENTARY INFORMATION

1. The Nationhood Material Program is administered by the Department of Finance. It enables Senators and Members of Parliament to purchase items including flags, national symbols posters, national anthem CDs/DVDs/USBs, and official portraits of the Royal Family, for presentation to constituents or organisations, for the purposes of conducting parliamentary business.
