- The Government conducted a rigorous process to find the best candidates, considering skills and experience against the requirements of the National Reconstruction Fund Corporation Act 2023.
- The Board's specialist knowledge spans the NRF's seven priority investment areas.

Talking Points

- On 9 August 2023, Shareholder Ministers announced the Board of the National Reconstruction Fund:

- On 20 October 2023, Shareholder Ministers announced an additional appointment to the Board:

- The NRF Board is to be made up of a Chair and 6-8 Board members. \$ 34(3)
- The Act stipulates the Minister makes appointments, however Cabinet convention as outlined in the Cabinet handbook specifies a significant appointment should be considered by the Cabinet.
- The Minister needs to be satisfied that Board members have experience, expertise and professional credibility across the following areas;
 - o banking and finance;
 - o venture capital, private equity or investment by way of
 - o lending or provision of credit;
 - o economics;
 - o government funding programs or bodies;
 - o accounting;
 - o law;
 - o a priority area of the Australian economy;
 - o industrial relations:
 - o industry growth;
 - the commercialisation of innovative research:
 - o any other field that the Ministers consider appropriate.
- The Minister also needs to give regard to the balance of these experiences. See <u>attached</u> some analysis I've done to ensure an appropriate balance is met.
- Board members are appointed on a part time basis. Board members are currently remunerated at \$61,420 annually, with Tier 1 travel.
- If another Board member was to be appointed, Minister Husic would need to write to the Prime Minister.

You may recall that on 9 August, <u>Minister Husic announced</u> the inaugural NRF Board, which included,

- Martijn Wilder AM (Chair) the Founder and CEO of Pollination and has previously held positions including Chairman of the Board of Australian Renewable Energy Agency, Founding Director of the Clean Energy Finance Corporation, Director of the Climate Council, Chair and Governing Board Member of Renewable Energy and Energy Efficiency Partnership and Chairman of Low Carbon Australia Ltd.

- The Hon Kelly O'Dwyer currently a Non-Executive Director of Barrenjoey, Equity Trustees, and HMC Capital. Previously served as a member of the Australian Parliament for over nine years. Held a number of senior economic portfolios including Minister for Jobs and Industrial Relations and Minister for Revenue and Financial Services.
- **Daniel Petre AO** Co-Founder and Partner Emeritus of AirTree, the Chair of Vera Living, and a Director of MetaOptima Technology Inc. He is also an Adjunct Professor at UNSW and a member of the UNSW Centre for Social Impact's Advisory Council.
- Kathryn Presser AM currently the Chair of the South Australian Department of Treasury
