Implementation of the Review of Integrity Concerns and Governance Arrangements for the Management of Regional Processing Administration by the Department of Home Affairs (the Richardson Review)

Lead: Ms Stephanie Foster PSM, Secretary of the Department of Home Affairs

Action required

- <u>Note</u> the update from the Secretary of the Department of Home Affairs on the implementation of Recommendations 1 3 of the Richardson Review.
- <u>Note</u> the Department of Home Affairs will return later this year to provide a final update and seek closure of Recommendations 1 and 2 as they transition to core business.
- <u>Note</u> the complexities associated with the implementation of Recommendation 3 and the ongoing work underway to consider the development of an appropriate information sharing protocol.

Key issues

- 1. On 31 July 2023 the Minister for Home Affairs announced the appointment of Mr Dennis Richardson AC to conduct a *Review of Integrity Concerns and Governance Arrangements for the Management of Regional Processing Administration by the Department of Home Affairs* (Richardson Review). The Terms of Reference for the Richardson Review are at *Attachment A.*
- 2. The Richardson Review considered integrity concerns related to the Department of Home Affairs' current and historic regional processing contacting arrangements and administration, which encompassed governance arrangements, oversight processes and systems for managing offshore processing, including engagement of sub-contractors by head contractors.
- 3. The Government released its **response** to the Richardson Review alongside an unclassified version of the report on 12 February 2024.
- 4. The Richardson Review made four recommendations:
 - a. Recommendations 1 and 2 principally relate to the Department of Home Affairs improving its risk management practices and culture to ensure the operating environment and the ethical conduct and integrity of tenderers is considered in procurement and contract decision-making for regional processing arrangements; and to promote an 'ask and tell' operating environment.

- The Government **agreed** with both recommendations and noted the Department of Home Affairs would lead implementation.
- b. Recommendation 3 relates to the development of a Commonwealth protocol to lawfully share law enforcement and intelligence information to inform procurement and contracting activities. The Government **agreed in principle** to this recommendation with the Department of Finance (Finance) and the Attorney-General's Department (AGD) in consultation with relevant law enforcement agencies and the Office of National Intelligence (ONI) on behalf of the National Intelligence Community (NIC) to lead consideration of a protocol or other arrangement for the lawful and appropriate disclosure of law enforcement and intelligence information to, and its use by, Commonwealth entities to inform procurement and contracting decisions in high risk environments. This will include regard to the legal frameworks that regulate information-sharing as well as operation and resourcing implications.
- c. Recommendation 4 is classified and is redacted in the public report.

Implementation Progress

5. Implementation milestones for Recommendations 1 – 3 are summarised in *Attachment B* – *Richardson Review Recommendation Implementation Plan*.

Recommendation 1 and 2

- 6. Recommendations one and two relate to the internal processes and culture of the Department of Home Affairs. Prior to the finalisation of the Richardson Review, work had already commenced to further enhance processes in regional processing procurement and contract management as a result of internal and external audit activity.
- 7. This work has encompassed policy updates to procurement and contracting procedures, guidelines, and frameworks; the establishment of more robust risk and integrity communication with stakeholders; and identification of cultural change lines of effort.
- 8. The Department of Home Affairs has established a Transformation Division, which will take forward a culture refresh which will support the creation of an 'ask and tell culture'.
- 9. Implementation of these cultural reforms will be ongoing and will be embedded within core business and reviewed on an ongoing basis.
- 10. Work recently undertaken by Finance that will assist the Commonwealth and address Recommendations 1 and 2 regarding the ethical conduct of tenderers and improved supplier integrity include:
 - a. the release of an 'Ethical conduct of tenders and suppliers' policy note for whole of government application, reminding entities of the requirements under the Commonwealth Procurement Rules to consider supplier's past ethical behaviour
 - b. changes to the Commonwealth Contracting Suite (CCS) and ClauseBank in May 2023 to include the Notification of Significant Events clauses
 - c. the development of a Commonwealth Supplier Code of Conduct to strengthen integrity and ethical conduct in its operations and that of its suppliers who deliver goods and services (industry consultation on the Code opened on 15 December 2023 and closed on 1 March 2024 and it is anticipated that the Code will come into effect in mid-2024).

11. Mr David Tune PSM has been appointed to review all procurement frameworks, processes and practices, to ensure they are robust, fit-for-purpose and align with respective Commonwealth principles/best practice. This review will be finalised by 30 June 2024.

Recommendation 3

12. Finance and AGD are leading engagements with relevant agencies, including the Australian Federal Police (AFP), ONI and the Department of Home Affairs, on the potential scope and risks which would need to be managed when establishing a protocol to lawfully share law enforcement and intelligence information.



- 14. AGD and Finance will continue to engage with relevant agencies to scope the development of a protocol, or other arrangement that meets the intent of Recommendation 3 of the Richardson Review, and report back to Secretaries Board later this year, as required, noting that the review recommended that any protocol be endorsed by the Secretaries Committee on National Security.
- 15. In accordance with the Government response to Recommendation 3, any protocol or arrangement will also need to be consulted with each NIC agency prior to endorsement.

Other work underway to support integrity of contracting in high-risk environments

16. The Board should note that while ongoing consideration will be given to the appropriate development of a protocol or otherwise, there has been, or is, work underway to address the intent of Mr Richardson's recommendation which includes:

Review of Integrity Concerns and Governance Arrangements for the Management of Regional Processing Administration by the Department of Home Affairs

Terms of Reference

Review of Integrity Concerns and Governance Arrangements for the Management of Regional Processing Administration by the Department of Home Affairs, noting:

- Allegations reported by 60 Minutes and the Nine papers relating to the Department of Home Affairs'
 management of regional processing contracts with Broadspectrum, Canstruct, Paladin, Management
 and Training Corporation (MTC) and other contractors over approximately the last decade; and
- Previous and ongoing investigations and inquiries into related matters, including by the Australian Federal Police and AUSTRAC.

An independent eminent person will be appointed to conduct a review of the contractual arrangements regarding regional processing, managed by the Department of Home Affairs and its predecessor, the Department of Immigration and Border Protection. The review will cover:

- Any integrity concerns about contracting arrangements regarding regional processing, whether public or otherwise, including the allegations and concerns raised by 60 Minutes and the Nine papers;
- The Department's governance arrangements, oversight processes and systems for managing offshore
 processing, current and historic, including in relation to the engagement of sub-contractors by head
 contractors;
- Any other related concerns regarding arrangements for regional processing administration.

The review will not consider the policy of regional processing.

The review will:

- Review the handling of any matters in the public realm and detail any matters of concern not in the public realm;
- Where appropriate, make recommendations for referrals to bodies for investigation (e.g. AFP, NACC);
- Where appropriate, make recommendations to ensure that the Department's processes and systems meet Australian standards for propriety and probity.

In conducting the review, the reviewer should:

- Have regard to previous and any ongoing investigations, including by the AFP, AUSTRAC and the National Anti-Corruption Commission;
- Seek information, as appropriate and necessary, from any Commonwealth agencies to support this
 inquiry.

The reviewer will be engaged by the Secretary of the Department of the Prime Minister and Cabinet and supported by that Department, with costs to be met by the Department of Home Affairs.

The review will report to the Minister for Home Affairs and the Minister for Finance (the Ministers) by 30 September 2023, for consideration of the National Security Committee of Cabinet.

If the Supplier fails to comply with these clauses, it will be treated as a breach of the Contract which entitles the Customer to terminate.
