- On 7 July 2020, the former Minister of the Environment, the Hon Sussan Ley MP, received an application under section 10 of the *Aboriginal and Torres Strait Islander Heritage Protection Act 1984* (Cth) (ATSIHP Act) for an area described as Ravensworth, Bowmans Creek and Glennies Creek in the Upper Hunter Valley, New South Wales (NSW) (specified area).
- 2. The application seeks protection for the specified area from the claimed threat of injury or desecration from underground and open cut mining activities including associated works like creek diversions by a number of proponents including Glencore.
- 3. On 27 August 2020, the former Minister appointed Mr Daniel Leo to provide her with a report under section 10 of the ATSIHP Act.
- 4. On 7 June 2021, the reporter submitted the section 10 report.
- 5. On 28 October 2022, the NSW Independent Planning Commission (the **Commission**) refused approval for Glencore's Glendell Continued Operations Project (SSD-9349) and associated application to modify the Mount Owen Continued Operations Project (SSD-5850-Mod-4). The referral was lodged with the commission on 22 February 2022. However, this is only one of the projects within the specified area.
- 6. There are no statutory timeframes for the making of a decision under the ATSIHP Act.


