- 5. The covid vaccines did not comply with the meaning of safe and effective and it was false and misleading of the health officials, politicians and celebrities to insist otherwise.

# **Family Circumstances**

6. I am divorced with three children, who are as follows:



- 7. I have six grandchildren, ranging in ages from two years old to 13 years old.
- 8. I have one brother and two sisters, two of whom live in and one of whom lives in
- 9. Up until my injuries received as a result of my first dose of AstraZeneca on 9 October 2021 ("the vaccine"), I was very actively involved in my children and grandchildren's lives, including regularly playing in the back yard with them and going to their soccer games, baseball games and cricket games.

10. Since I have been affected by the vaccine, my quality of life has severely been affected, and I am no longer able to participate in my children and grandchildren's lives as I did before.

## **Living Circumstances**

- 11. I live by myself at the address which appears above.
- 12. I have been living by myself at that same address since in or about 2005.
- 13. Until I sustained the injuries from the vaccine, I was completely self-sufficient in my home and independent, including but not limited to independently performing the following tasks:
  - (a) maintaining and restoring my home;
  - (b) maintaining the external gardens; and
  - (c) undertaking all of the housework and general duties involved in the upkeep and maintenance of a home.
- 14. My house is a three-bedroom house with a large loungeroom and a lovely back yard and front yard. It is made of brick.
- 15. Since being injured by the vaccine on 9 October 2021, I have been unable to affect any of the above, including the maintenance and restoration of the home, looking after the gardens (which I found much joy in) and undertaking the general household work on a day-to-day basis.

### **General Health Prior to Receiving the Vaccine**

- 16. I was in generally very good health for my entire life until the injuries I suffered as a result of the vaccine; however, I did have in 2012.
- 17. I did not receive any or other treatment, but I did have a
- 18. Additionally, I am a smoker and have been smoking since I was approximately 18 years of age.
- 19. However, prior to receiving the vaccine, I was in generally good health. I would walk between five and six kilometres per day on most days, and on weekends I would walk along the beach with a friend. I have a home gym, and I was fit and active and would work out regularly, on most days of the week.

- 20. Since my symptoms started following the vaccine, I have not been able to undertake any of those activities at all.
- 21. Now, in order to rehabilitate I undertake the following:
  - (a) one hydrotherapy session per week;
  - (b) one physiotherapy session per week; and
  - (c) three exercise physiology sessions per week.
- 22. I have had the same general practitioner ("**GP**"), who deals with my day-to-day health matters, since the early 2000s. My GP is and has been at


- 23. Until October 2021, I worked in the car restoration field undertaking car body repairs and restoration. I had worked for the previous two years for "
- 24. I have been in the car restoration field since in or about 1974.
- 25. I had no plans to retire. In fact, my plan was to work full-time until I reached the age of 67 and then, after that, work on a part-time basis for as long as I was able to.
- 26. When I received the vaccine on 9 October 2021, I suffered injuries which are particularised below, and from 18 October 2021 I was unable to work as a result of those injuries.
- 27. I recall telephoning my employer from hospital and advising them that I was in hospital and unlikely to return, given the extent of my injuries at that time.
- 28. At this time, I cannot envisage returning to work, given the injuries I continue to suffer and the continuing situation of my health as at today's date.
- 29. My doctor, confirmed same in an appointment I had with him approximately two weeks ago. He said it is very unlikely I am ever to work again, given the injuries I have sustained as a result of the vaccine.

Details of Vaccination, Subsequent Hospital Admission and Ongoing Symptoms and Treatment

- 30. In late September or early October 2021, I was scheduled to have dental surgery undertaken because I needed in my mouth. In order to attend at a hospital so that that surgery could be undertaken, it was a requirement that I be vaccinated.
- 31. It was not a requirement of my employer that I be vaccinated.
- 32. Accordingly, on 9 October 2021 I received my first and only dose of AstraZeneca.
- 33. I attended at the vaccine there on 9 October 2021.
- 34. Approximately three days after receiving the vaccine, I started feeling pain between my shoulder blades. It was a weird pain that I had not previously experienced; it was a sharp, stabbing pain.
- 35. The Wednesday, Thursday and Friday following, being 13, 14 and 15 October 2021, continued in the same vein, then worsened. During this time, I started feeling pain in my arms.
- 36. On the Sunday, being 17 October 2021, I experienced extremely bad lower back pain.
- 37. The next day, Monday, being 18 October 2021, I experienced lower limb numbness and weakness, including that I could not feel the soles of my feet.
- 38. I stayed home from work on that Monday and Tuesday.
- 39. On the Wednesday, being 20 October 2021, I lost all bladder function. I could not pass urine at all. I had
- 40. On Thursday, 21 October 2021, I called an ambulance from my home because of the severe pain I was in. I was taken by ambulance and later on 21 October 2021 was admitted to the Hospital.
- 41. The first thing which occurred in the Emergency Department was that a catheter was inserted, and one litre of fluid was removed at that time.
- 42. They then shifted me to general admission because they thought I had a back injury.
- 43. The medical staff at the hospital were very difficult to convince that I had vaccine-induced injuries. I had to advocate on behalf of myself strenuously to get anybody to hear me in relation to the cause of the injuries. They kept assuming that I had a back injury, but I had not had any accident whatsoever which would cause the pain and injury I was experiencing.
- 44. I recall that I said to them that it was either Guillain-Barré syndrome or transverse myelitis.

45.	Eventually, after shouting at them on an ongoing basis until they heard me, they had their neurological team assess me.
46.	That only occurred after I told them I would be a private patient.
47.	The neurological team did a and an and an and an an and an analysis. From that assessment, they moved me immediately to the neurological ward. As a result of that assessment, they found the following:
	(a) I had lesions (acceptable)
	(b) I had and a second of the
	(c) I had on the lower part of same.
48.	Originally, the neurological team said that there was no way that my symptoms and the lesions could have been caused by the vaccine.
49.	I subsequently read in the medical notes recorded in relation to that hospital admission that the neurological team consulted with the hospital's legal department and were advised by the legal department to remain non-committal in relation to the causes of the lesions.
50.	I recall, at the time, being visited by several nurses who were in tears on my behalf because they were trying to have me assessed by the neurological team and for somebody to take heed that the cause was actually the vaccine.
51.	It was an extremely traumatic time for myself and my family.
52.	This was exacerbated by the COVID-19 restrictions at the hospital, which included a rule that I could only have one visitor per day for a limited period of time. So if my son came down with one of my grandchildren, I could not see them.
53.	I was in immense pain, having to advocate for myself, and the doctors were not listening to me or giving any credence to the fact that my injuries were COVID-19 vaccine-related.
54.	It was only because my private neurologist, took my issues seriously that I ultimately received an indication that my issues were caused by the vaccine. With that said, I recall that at the time said that he would support me 100 per cent but couldn't say that my issues were caused by the vaccine because of pressure on him within the medical field.
55.	It was clear to me that was of the opinion that or knew that my injuries were caused by the vaccine.
56.	As stated in the letter from (clinical immunologist and allergist at the

dated 13 April 2022, the treating team who assessed me at the



- 57. I was never admitted to the but I did attend there for a follow-up assessment in order to have the letter written which would allow me to obtain exemption from any further vaccines.
- It is worth noting here that, given the treatment I received, I spoke to my local Minister of Parliament and he ended up having a meeting with in relation to the issues that I was facing.
- 59. I continued to be admitted at until 12 November 2021. On 12 November 2021, I was transported to there until 23 January 2022.
- 60. For my entire admission, I was essentially bedridden and needed a wheelchair to move around.
- 61. When I left the rehabilitation centre, I still needed a wheelchair because I had no strength in my legs or control over my legs. I was unable to walk.
- 62. I still take every day to treat the pain that I continue to suffer.
- 63. In terms of my current mobility, I can maybe walk 50 metres when I am assisted by crutches. In order to travel any further than 50 or so metres, I require use of a wheelchair for mobility.
- 64. As at the date of writing this submission, I still continue live with consistent pain on a daily basis. My feet remain numb still, to this date.

66. As a result of the above, I have lost trust in medical professionals and the government because of the way I was treated and the damage I have sustained due to the vaccine, a

vaccine I was essentially forced to get in order to obtain general dental work.

## COVID-19

65.

- 67. In or about February 2022, I was infected with COVID-19.
- 68. I had mild cold symptoms for two days and did not receive any medical assistance to treat that COVID-19 infection.

### **COVID-19 Vaccine Claims Scheme**

- 69. My case has been accepted by the COVID-19 Vaccine Claims Scheme ("**the Scheme**"), and I anticipate I will receive some funds from that, which I understand will be offset against any funds I receive as a result of these proceedings.
- 70. The process of recovering compensation through the Scheme has been extremely long and frustrating. In fact, they have requested copies of tax returns from my employer on the basis that they thought one of the owners, namely was me; however, that is my son.
- 71. I await further contact from the scheme in relation to the quantum of compensation I will receive as a result of the Scheme,

### Summary

- 72. I am devastated as a result of my injuries sustained due to the vaccine, and my life has been completely destroyed.
- 73. My passion was hot rods, and I own hot rods vehicle, but I cannot drive them because I can no longer drive a manual vehicle at all and will likely never be able to drive a manual vehicle again for the remainder of my life.
- 74. I was an avid rock 'n' roll dancer, and I will never be able to rock 'n' roll dance again.
- 75. Prior to obtaining an injury from the vaccine, repairing hot rods (both in a work capacity and as a hobby) and rock 'n' roll dancing were an integral part of how I interacted socially with the wider community and maintained friendships. Since I have been injured by the vaccine, rendering me incapable of participating in either, I feel that I have become withdrawn and isolated; my social life and, consequently, my mental health have suffered greatly as a result.
- 76. My relationship with my children and grandchildren was once one of activity and fun times; however, since I obtained injuries as a result of the vaccine, I have been robbed of those interactions now and into the future.
- 77. I am unable to complete daily tasks like my own housework and generally looking after myself.
- 78. I suffer daily from the pain of my ongoing injuries.
- 79. This brings me severe feelings of sadness, and although I have had no mental health-related diagnosis or treatment, I know that my feelings have been extremely affected by both my physical pain and physical disability.
- 80. Further, I am affected on a daily basis by the knowledge that I will likely never again be able to participate in my passions and hobbies, once such an integral part of my life, or

act as an active participant in the lives of my family. This knowledge brings me great sadness when I reflect on the life I might have enjoyed if not for the injuries I now suffer as a result of the vaccine.

81. We need to have a full royal commission on the covid response, covid vaccine and the lack of true testing and the government covid vaccine compensation scheme which is neither simple or quick as described by the prime minister or his agents, it's a bit like safe and effective.
